The following terms and conditions apply:

**Preamble**

The member is entitled to participate in all classes offered to members in their age group, excluding special classes for professional martial artists. Special rules apply to children aged 5 to 12. In addition, they are also allowed to use the strength and cardio equipment and sauna (both from the age of 15), the cardio area, and the showers. They are also permitted to be in our lobby during the opening hours.

§1 The Membership begins \_\_\_\_\_ and is initially for a period of: **1 | 3 | 6 | 12 | 24** month(s) (circle applicable number). If neither MMA Mixed Martial Arts GmbH nor the member has properly or extraordinarily terminated an expiring contract with a term longer than three months, the contract will be automatically extended by a further six months. This also applies continuously after automatic or expressly agreed further extensions.

§2 Contracts with a term of up to three months do not require termination, but will instead expire automatically. Longer-term memberships can be terminated with one months' notice prior to the end of the contract period. The termination must be made in writing and with the member's original signature or via email only sent from the member's provided email address to [info@mmaspirit.tv](mailto:info@mmaspirit.tv) ; verbal terminations will not be accepted. The date the written notice is received by MMA Mixed Martial Arts GmbH is used to determine whether the deadline has been met. If the termination is not made on time, the contract will automatically extend for six months as described in §1 above. Memberships can be terminated no earlier than four weeks after its start.

§3 The right to extraordinary termination in the event of a permanent and medically certified inability to exercise, a move of the customer's sole domicile further than 60 km to MMA Mixed Martial Arts GmbH (unless this was already the case when the contract was concluded), being called up into the armed forces, or pregnancy is not affected. The time at which all the necessary documents are submitted is decisive for the implementation of an extraordinary termination, since a refund of any dues is excluded in any case. Regardless of the reason for the extraordinary termination, the dues for the term actually used shall become due immediately upon termination of the contract. The difference is based on the membership fees advertised on our homepage [www.mmaspirit.tv](http://www.mmaspirit.tv) and displayed in the gym at the extraordinary termination takes effect. The right to extraordinary termination does not apply to all dues paid in cash or in advance in exchange for a reduction in dues. A refund of dues is excluded in any case.

§4 A one-time registration fee of €\_\_\_\_\_ will be charged; it is payable in **cash** or by **SEPA** direct debit mandate (circle choice) by \_\_\_\_\_

§5 The membership card costs €10.00 cash. The member agrees to present the membership card to an employee at our reception every time they visit the MMA Mixed Martial Arts GmbH. If the magnetic stripe of the card is damaged and is no longer legible, the member must immediately purchase a new card for €10.00.

§6 Optionally, the membership fee of €\_\_\_\_\_ can be debited on the **1<sup>st</sup> | 15<sup>th</sup>** (circle choice) of each month in advance from the account indicated on the back by means of a SEPA direct debit mandate or the total dues for the membership term in the amount of €\_\_\_\_\_ will be paid in cash every **6 | 12 | 24** (circle choice) in advance. The membership fee is a special offer: **YES | NO** (circle appropriately)

§7 If the member would like to switch from advance payment of the membership fees in cash to SEPA direct debit after the original term or upon the expiry of an extension term, the current posted registration fee is due immediately and without delay.

§8 In addition, the member has chosen to book our beverage flat rate service for the duration of the agreed membership period **YES | NO** (circle choice). The member agrees to use only the beverage bottle we provide at no charge and to use said bottle at our mineral water dispensers for a monthly fee of €\_\_\_\_\_. The beverage fee will be paid in the same manner as the membership dues. Sharing of beverage bottles is strictly prohibited. If the previous bottle is lost or defective, the new bottle must be purchased for €10.00 cash.

§9 If the member has not yet reached the age of 15 when the contract is concluded, the dues are € \_\_\_\_\_. Upon reaching the age of 15 on \_\_\_\_\_, the dues will increase to €\_\_\_\_\_.

§10 Members who are already 15 or older will not see an increase in their dues during the initial term. See §9.

§11 The member agrees that the membership dues will be increased to the current and advertised dues for 6 months of membership after the end of the initial term.

§12 If the member is in default of payment, MMA Mixed Martial Arts GmbH is entitled to discontinue its services. This does not release the member from their payment obligations.

§13 Changes to address and changes to account, telephone, or email contact details must be reported to MMA Mixed Martial Arts GmbH immediately. Failure to provide such notice will result in any costs incurred being billed to the member.

§14 The member agrees to adhere to the current version of the house rules as posted.

§15 Damage to the facility of MMA Mixed Martial Arts GmbH is to be reimbursed by the perpetrator, if necessary by their liability insurance. Corresponding information obligations are incumbent on the member. MMA Mixed Martial Arts GmbH reserves the right to issue a written ban in the event a member is in violation of the house rules and/or good morals. Such a case includes an ordinary termination effective the end of the current term; dues will continue to be payable until such time.

§16 If it becomes impossible for MMA Mixed Martial Arts GmbH to provide certain services due to force majeure, the member has no right to compensation or replacement hours.

§17 The member warrants that they will only use the techniques learned in the martial arts courses in sports competitions, in training units at MMA Spirit, or in the sense of the self-defence per §32 of the German Penal Code (StGB). In the event of a violation of this provision, MMA Mixed Martial Arts GmbH reserves the right to terminate the contract without notice.

§18 The MMA Mixed Martial Arts GmbH is entitled to assign its claims from this membership contract to the external service provider, Eurofit24 GmbH, Raboisen 6, 20095 Hamburg, and to transfer the collection of claims to the same.

§19 The member agrees that images (photos/videos) of their person that may be created on the premises of MMA Spirit for advertising purposes, may be used by MMA Mixed Martial Arts GmbH on its Instagram and Facebook feeds and on its homepage without restriction.

§20 The member would like to receive emails concerning important information about their contract and other offers.
